Enclosed are the Modified Part 360 Series Solid Waste Management and Air State Facility Permits and the 401 Water Quality Certification. Please note the new effective date and expiration date. A copy of the Findings Statement is also included. A copy of the Permit Application Responsiveness Summary is attached to the Findings Statement.

The permittee should review the revised regulations to insure the landfill's compliance with any upcoming requirements, including, but not limited, to the requirement to submit a deed description, in one year, in accordance with 6 NYCRR 363-7.1(r) and to have an updated financial insurance instrument in place 60 days prior to operation of the new cell per 6 NYCRR 360.22(a)(1). The noise monitoring system also needs to be in place prior to operation of the new cell.

Please review the enclosed modified permits carefully. Please note that under 6 NYCRR Part 621.7(f) of the Uniform Procedures Act, if a permit for a project is denied, or is issued with significant conditions attached and an adjudicatory public hearing was not held, then the applicant may request that one be held. Such a request must be made within 30 calendar days of the date of the mailing of either the notice of denial or the permit with conditions.
