**Project Description:** 

The applicant proposes to build a three-building materials processing and recovery facility that would accept construction and demolition debris (C&D), non-hazardous industrial waste, non-hazardous sludges, and contaminated soils, with an average daily throughput of 106 tons and maximum throughput of 2,000 tons per week. The facility will include waste storage areas, a scale house, an onsite holding tank and a leachate pre-treatment system, and a building for handling and storage of waste materials that will also have areas for office space.

All materials other than select C&D debris will be handled indoors. Materials will be separated, decanted, solidified, reduced, and/or consolidated, based on the material type, before being transported to their final destination.

Normal operational hours are proposed for 7:00 a.m. to 5:00 p.m., Monday through Saturday.

# Project Description:

The applicant is proposing to construct approximately 360 LF of a single low pressure 2" natural gas pipeline via Horizontal Direction Drilling (HDD) bore through NYSDEC regulated Class 2 Freshwater Wetland (FWW) RX-1 and its associated 100-foot Adjacent Area (FWAA). The entry and exit pits for the HDD bore will be located outside the regulated FWW and the FWAA. Approximately 180 LF of this 360 LF section of pipeline will be drilled under the bed and banks of Marsh Creek, a class C(T) tributary to Cryder Creek. The pipeline will be drilled at least 15 feet below the bed of Marsh Creek. The total length of pipeline to be constructed is 1.3 miles; this will be a collector line for existing oil wells and will connect to an existing natural gas pipeline. The proposed pipeline will capture natural gas byproduct from the oil wells that is currently being flared. Consistent with Climate Leadership and Community Protection Act (CLCPA), an analysis was provided within the application regarding the regarding the project's consistency with the statewide greenhouse gas (GHG) emission limits.
